### **Greetings CEA members!**

Now that we have a tentative agreement in hand, it's important that each and every eligible member has the opportunity to cast their vote to ratify our new contract.

#### Here's what you need to know:

1. The most secure and accurate way to conduct a ratification vote is by using NEA-Alaska electronic voting platform. This will ensure every



- eligible member can only cast one vote and will provide instant results once the voting window has closed.
- 2. CEA is committed to ensuring everyone has the opportunity to vote, either at home, on their mobile device, or by visiting the CEA office.

  NEA-Alaska staff will be on hand during voting to verify membership, provide access to the ballot, and ensure votes are successfully cast.
- 3. While voting is open, CEA will be reaching out with emails and text messages reminding members to vote. In the emails, you'll find the link to vote along with your login credentials for an easy process.
- 4. If you have any difficulties voting, please contact <a href="Malina.Colon@neaalaska.org">Malina.Colon@neaalaska.org</a> for assistance, or call the CEA office.
- 5. Once the voting window has closed, CEA leadership will verify the totals and announce the outcome to members and the District.
